MINUTES OF THE FIRST MEETING OF THE GRANTS COMMITTEE

A meeting of the Grants Committee for the above scheme was held on 29-30 August 2006 in National Archives of India, New Delhi under the Chairmanship of Shri K. Jayakumar, Joint Secretary, Department of Culture, Government of India:

Dr. M.V. Nair, Director, National Research Laboratory for Conservation of Cultural Properties, Lucknow, who was invited as an Expert to assist the Grants Committee, could not attend the meeting.

Welcoming the Members, the Chairman informed them about the aims and objectives of the scheme and also the maximum limit of the Financial Assistance admissible under it.

The Member Secretary informed the Committee that out of a total of 153 proposals received in response to an advertisement published in the national dailies on 28 April 2006, 14 proposals were found outside the purview of the Scheme, and therefore, these were not included in the present Agenda. Similarly 20 proposals received after the finalization of Agenda (i.e. 14 August 2006) were also not included in the present Agenda, and these proposals will now be processed for the next meeting of the Grants Committee.

Subsequently, 138 proposals received from different Voluntary Organizations/ Universities/ Individuals etc. seeking Financial Assistance were taken up for consideration. These included 113 proposals where all papers were complete and no utilization certificate was pending and 25 proposals were those where papers were not complete and or utilization certificate for the earlier grant were pending. The Grants Committee unanimously decided that in view of the provision of the GFR 2005 as well as orders of the Hon'ble Delhi High Court in CWP no.6413/2000 no financial assistance can be sanctioned to any grantee, against whom a utilization certificates for previous grants is pending. The Committee therefore, decided to reject proposals from all such Institutions/ Individuals where utilizations certificates for previous grants were pending. The Committee directed that letters to these Institutions/ Individuals may be sent immediately asking them to settle their cases at the earliest by submitting utilizations certificate/ other relevant papers to avoid penal action as per rules.

Thereafter, the cases were considered seriatim and the following decisions were taken:

1. Rs.47,61,885 (Rupees forty seven lakhs sixty one thousand eight hundred eighty five only) being of 75% of Rs.63,49,180/- (Sixty Three Lakhs Forty Nine Thousand One Hundred Eighty Only) worth of projects approved by the Grants Committee were recommended to 71 organizations/ individuals as per the list at **Annexure - I**.
2. The Grants Committee did not recommend Financial Assistance to 67 Organizations/ Universities/ Individuals etc. due to reasons like non-receipt of State Government/Archives recommendations, pending Utilization Certificate for the grants given earlier and in the absence of any specific information about their holdings viz. Manuscripts/ rare books etc. The list of these rejected cases is given at **Annexure - II**.
3. The case of Shri Ram Charan Prachya Vidyapeeth and Sangrahalaya Trust, Jaipur, Rajasthan to whom a grant of Rs.1,00,000/- was sanctioned during 2002-03 was then taken up for consideration. The grantee had diverted Rs.50,000 (Rupees fifty thousand only) for purchase of computer. After deliberations it was decided that although purchase of computer is not permissible under the scheme, the aforesaid amount may be ratified as a special case since the grant was utilized for the purpose for which it was given as evinced from the hard and the soft copies of the catalogue supplied to this Department.


Dr. A.K.V.S. Reddy, Director General, National Museum, New Delhi and Dr. V.Kutumba Shastri, Vice Chancellor, Rashtriya Sanskrit Sansthan, New Delhi could not attend the meeting.

Welcoming the Members, the Chairman apprised them of the aims and objectives of the scheme and also the maximum limit of the Financial Assistance admissible under the scheme. Subsequently, proposals received from 23 Voluntary Organizations/ Universities/ Individuals seeking financial assistance were taken for consideration within the parameters of the scheme and the following decisions were taken:

1. Grants Committee recommended Rs.16,30,000/- (Rupees Sixteen Lakhs Thirty Thousand only) to 18, Organizations/ Universities (**Annexure-I**)
2. The Grants Committee did not recommend Financial Assistance to 5 Organizations/ Universities/ Individuals etc. due to pending utilization certificate and in the absence of any specific information about their holdings viz. Manuscripts/ rare books etc. The list of these rejected/ deferred cases is given at (**Annexure - II**)
3. As a special mention, the case of Bombay Natural History Society (BNHS), Mumbai was placed before the Grants Committee. A grant of Rs.1,83,000/- (Rupees One Lakh Eighty Three Thousand only) was given to BNHS during 1999-2000. However, the grantee did not utilize the grant for the purpose it was given, and later decided to refund the entire grant amount. The National Archives of India then requested the BNHS to return the entire grant amount with penal interest of Rs.81,435/- from February 2000 to November 2006 (calculated @6% per annum from February 2000 to June 2005 and @10% per annum from July 2005 to November 2006 vide General Financial Rules (GFR),2005). The BNHS has then requested to waive the penal interest.


The Member Secretary informed the Grants Committee that the case of BNHS, was a sampler of many such cases where grant money remains unspent for a number of years beyond the utilization period and then a request is made to waive off the penal interest. The Grants Committee observed that the waiving of penal interest was not within its jurisdiction and our experience in the past to take up a similar matter with the highest authorities of the Government of India was such infructuous. As such the request of waiving of penal interest cannot be acceded to.

The meeting concluded with a Vote of Thanks to the Chair.
