INTRODUCTION

The Research and Publication Committee of the Indian Historical Records Commission in its report of 1944 on the post-war reorganisation of Archives Offices in India had recommended that micro-copies of all rare publications on India, not available within the country, should be obtained irrespective of the period dealt with by them. Three years later the National Archives of India took up this ambitious programme with due modifications. In view of our country's limited resources, it was decided to acquire microfilms from abroad with the main objectives of filling up the gaps in the series of records in the Department's custody as also to supplement information available in them. The task did not prove to be an easy one. Despite the modification of the programme, the real difficulty in accomplishing the objective has been the inadequate foreign exchange. More difficult were the tasks of gathering detailed information about the extent and availability of materials, making selections from the vast quantities of records and by negotiation with the concerned repository for obtaining microfilms of the items of our interest.

Notwithstanding these hurdles the National Archives of India has by now enriched itself by acquiring over 2600 microfilm rolls from the archival repositories located in Australia, Canada, Denmark, France, Norway, Netherlands United Kingdom, U.S.A., U.S.S.R. and other countries. By no means this is a small achievement inasmuch as the National Archives of India has built up a not too unimpressive microfilm collection of records of Indian interest found scattered outside the country.

The bulk of the acquisition of microfilms have been made against payment. A sizeable number of them have been received under the Cultural Exchange Programmes while a few have been obtained as gifts. While the majority of collections are in English those obtained from France, Netherlands, Iraq, Italy, U.S.S.R. etc. are in French, Dutch, Arabic Italian and Russian languages, respectively.

The Microfilm Collection has proved to be a big facility and boon to research scholars who are able to consult the relevant materials, at their own leisure, in the Research Room of the National Archives of India, without having to go abroad for this purpose.

The subject matter of the microfilms cover almost every aspect of the history of India from the beginning of the sixteenth century to our own times. In the following pages brief indication has been given of the nature of the material dealt within an individual collection. The information provided for is only illustrative and is by no means exhaustive. Particularly, the period covered by the materials is not necessarily that indicated in the short description and usually begins earlier and goes beyond the years mentioned. For specific information it is advisable to consult the manuscript list and catalogues available with the National Archives of India. This brochure is intended to kindle spirit of enquiry and to prompt the searchers into delving further investigations in what is contained among the microfilm rolls.

In building up this Microfilm Collection we have received help from many people in many places but I may thank Archivists and Librarians who have whole-heartedly cooperated with us in this arduous task. I must also put on record my appreciation of the ungrudging assistance given to me by Smt. Shukla Singh, Assistant Director of Archives and Shri B.D. Saxena, Archivist in bringing out this brochure in time to coincide with the celebration of the International Archives Week.
